If a Decedent IRA is being inherited by more than one beneficiary, this form should be completed by the branch to reflect the division of assets. If the assets are not being divided evenly per the designation signed by the deceased client the beneficiaries would need to sign the worksheet as well acknowledging the breakdown.

In determining the asset division, mutual funds can be carried out to a maximum of three decimal places, stocks can only be moved as whole shares, and bonds can only be moved in tradable increments. Share quantities are required. The percentage of each asset will not be accepted. Please make sure to include the security number/CUSIP. When trying to figure cash only, fill in the cash percentage box if you want the sheet to calculate; otherwise put the cash dollar amount in the additional cash box.
